Body Worn Camera Grant Opportunity

The U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) seeks applications for funding law enforcement agencies, prosecutors' offices, and correctional agencies performing law enforcement functions to purchase or lease body-worn cameras (BWCs) to establish or expand comprehensive body-worn camera programs with a specific and demonstrated plan to implement this technology to maximize the benefits of BWCs. Funding under this program also supports agencies with existing BWC programs that are seeking to improve the management, sharing, and integration of digital evidence generated from BWCs; optimize how prosecutors leverage BWC footage to improve operations; or use BWC footage to enhance officer training or constitutional policing practices. This program furthers the DOJ's mission by promoting the safe and fair administration of justice. **If you would like to apply, contact us.**

DOJ, OJP, and BJA Grant Applications are still open grants.gov applications are due April 4^h and JustGrants application is due April 11th.

As a reminder, the SRT BWC program is a Bureau of Justice Assistance (BJA) funded initiative, operated by Justice & Security Strategies (JSS). The purpose of this initiative is to provide funds and technical support to small, rural, and tribal agencies to implement body-worn cameras. Illinois Basin Funding Review

The Illinois Basin Funding Review (IBFR) is a unique approach to connecting community economic development projects with government funding and technical assistance. It is being organized by the Illinois Basin Rapid Response Team as part of the Interagency Working Group for Energy Communities (IWG) which was created in response to President Biden's Executive Order on addressing climate change. The Executive Order directs twelve federal agencies to target communities transitioning away from fossil fuel production or reliance with opportunities for funding. These federal agencies are partnering with State of Illinois agencies on the Rapid Response Team to provide in-person funding reviews and workshops to assist rural communities.

The first meeting, on March 7th, will include White and Wayne counties and Norris City will be presenting. On March 8th, the committee will share their project with attendees. In June, Crawford, Larwence, and Richland counties will have the opportunity to present as well.
